### BOARD ACTION

1. Accepted the April 30, 2010 Treasurer's Report and forwarded it to the Finance Committee for review.
2. Approved the proposed 2011 Barnes Memorial Scholarship slate of jurors: John Agraz, Arla Jo Anderton-Gideon, John Bordley, Roy Hamlin Johnson, Loyd Lott, Mary McFarland (alternate) and David Osborn (alternate).
3. Approved use of a three-year, fiscal year end trailing average of 5% each year to determine the amount available for Barnes Scholarship distribution for the current year, this to become an amendment to the Barnes protocol.
4. Presented the 2010-2011 proposed budget to the membership for approval.
5. Recommended that local materials such as summer concert programs include the GCNA logo and web address, this action not to be construed as endorsement of a local event, but rather a request for additional information.

6. Agreed to proceed with formation of the Associate Carillonneur evaluation process, as recommended by the *Ad Hoc* Committee, and charged an organizing committee headed by Margo Halsted to develop a detailed process, submit it to the board for comment, and in turn post a draft for general comment on the members only section of the website.
